


TWELFTH PARLIAMENT OF THE COOPERATE REPUBLIC OF GUYANA

Guyana = area – 83, 000 sq mls or 215,000 sq km = Pop – approx 800,000 +others 180,000

#### **85% FOREST COVER**

- Independence May 26 1966
- Republic Feb 23 1970
- 1980 constitution
  - Introduced the novel system in 1980 with an Executive President
  - 65 seats unicameral house with a Prime Minister who is the first VP
  - President can appoint 4 Technocrat Minister and 2
     Parliamentary Secretaries. They have no voting rights
  - We have ten Administrative Regions with 10 regional councils which are like state
  - 2000 MAJOR CONSTITUTIONAL REFORM

- THE UNIQUE HYBRID SYSTEM WITH SEATS ALLOCATED BY PR ON LISTS
- SO OUR SYSTEM WAS CHANGED FROM WHERE THE PM IS HEAD OF GOVERNMENT AND THERE IS A HEAD OF STATE
- IN THE CARIBBEAN DOMINICA, TRINIDAD AND TOBAGO AND BARBADOS ARE ALSO REPUBLICS.
- GUYANA'S SYSTEM HAS THE TRADITION OF BEING WESTMINSTER AND INTRODUCING THIS NEW SYSTEM.





OUR INDIGENOUS PEOPLE ARE CALLED THE AMERINDIANS

- ALMOST 15% OF THE POPULATION AND OVER 70% OF THE COUNTRY.
- WE HAVE
  - AMERINDIAN ACT
  - MINISTRY OF AMERINDIAN AFFAIRS
  - PARTIES HAVE MANY AMERINDIANS IN PARLIAMENT
  - POLICY OF PRIOR AND INFORMES CONSULTATION

LEGISLATIVE ASSEMBLY



### Context

- Population: 44,731
  - ~ 50% Indigenous
  - 33 Communities
  - 1.14 million km<sup>2</sup>
- Fully elected government since 1975
- Consensus Government
  - 19 MLAs, no parties
  - Territorial Leadership Committee
  - Executive Council always in minority position
- Northwest Territories Act



## Devolution

- Responsibilities for different functions were devolved from the Government of Canada to the Government of the Northwest Territories over many decades
- In 2014, after more than a decade of negotiations, the NWT became the second territory to take over land and resources responsibilities from the Government of Canada
- "Devolve and Evolve"



## Intergovernmental Council

- Devolution Agreement established an Intergovernmental Council for collaboration on matters related to lands and resource management
- Goal is to coordinate on best practice, share capacity, and avoid duplication of efforts



## Land & Resource Management: Legislative Development Protocol

- 18<sup>th</sup> Legislative Assembly:
   recommendations under the *Committee* Report on the Process Used for Devolution
   Legislative Initiatives
- 19<sup>th</sup> Legislative Assembly: Legislative
   Development Protocol between GNWT and the Intergovernmental Council



## Land & Resource Management: Legislative Development Protocol

- The Protocol formalizes the collaborative development process for NWT land and resource legislation
- Full and meaningful opportunity for all partners to engage and contribute
- Each partner determines their own level of involvement
- Bills drafted under the protocol are reviewed by the Intergovernmental Council Secretariat before introduction



## Process Convention on the Introduction, Consideration & Enactment of Co-developed Legislation

- Legislative Proposals are reviewed by a Committee of all Regular Members
- Complications identified in the process resulted in a convention on the introduction, consideration and enactment of co-developed legislation



# Process Convention on the Introduction, Consideration & Enactment of Co-developed Legislation

- Procedural differences are noted at:
  - Legislative Proposal
  - Introduction of Bill
  - Standing Committee Review
  - Clause-by-Clause Review
  - Committee of the Whole Review
  - Assent



## Looking Forward

- The Forest Act is the only statute developed so far pursuant to the protocol and associated convention
- Interest in expansion of co-development to bills on other topics



#### Recommendation



Parliaments should continue to adapt and innovate to strengthen their governance systems, while ensuring these efforts respect and engage with tradition and local context.
